DUN LAOGHAIRE BATHS UPDATE "East Pier to Sandycove Enhancement Scheme"

In our last issue, we headlined our front page "O BATHS, BATHS, WHERE-FORE ART THOU BATHS?" since we had heard nothing for over a year and a half. Shortly after that, Councillors attended a presentation at the Marine Hotel of the new proposals for the Scotsman Bay shores.



We were very disappointed that we were not invited along to a presentation, if not this presentation which was for Councillors only, at least an immediate follow up to ourselves, Sandycove and Glasthule Residents Association, and others like Save Our Seafront, who were to the fore in preventing the handover of the Dun Laoghaire Baths to a private developer for luxury apartments in an eight storey high building. We, like many others, have had to interpret those artist's impressions which appeared in the national media and subsequently in a very similar display of virtual reality artist's impression images on display at the County Hall. Our initial reaction is that there is very little detailed information available. It all looks rather wonderful! We feel at this stage we would not like to comment one way or the other until we receive more definitive details from our local ward Councillors.

Questions to be answered about the seafront proposals

Questions residents have at this stage are

- Where is the €129 million required for the more grandiose of the two schemes?
- When will the work start?
- When will the work be completed?
- Will parts of the plan be "cherry picked" and completed first? We worry that certain aspects of the plan, such as a car park for 500 cars might get the "green light" and the other amenity facilities could be put on the "long finger".
- How will the sea react to the dramatic change arising from the massive amounts of sand required to turn the Scotsman Bay shoreline into a "Brittas Beach"?
- How will the shoreline cope with the removal of the rocks from the area?
- How will our seafront cope with the influx of thousands of cars to avail of the golden sand facilities? Could this be a very large and grand white elephant?
- How will this 100 acre site be maintained? The County Council currently have difficulty maintaining sand and seaweed levels at the tiny Sandycove beach.

PATTON FLYER UNDER THREAT

As reported in recent editions of the national newspapers, the Patton Flyer might cease to fly and be grounded some time in the future. Rumours abound that this would come about as a result of taxi complaints, Bus Eireann unions etc, but apparently it all goes back to the necessity of a licence and Minister Dempsey appearing to favour some very out of date rules for the regulation of buses.

As word went around Sandycove and Glasthule, residents were quite outspoken and disgusted that the Patton Flyer might no longer pass through the streets of our area to and from the airport. "It is like a clock" said one resident. He stated that you knew it was exactly 5 past the hour when the Flyer heads through Glasthule for the airport and quarter to the hour when it returns in the direction of Dalkey.

This excellent and professional service to and from the airport from 4am until late at night has been widely welcomed. We wish Trevor Patton well in his endeavours to retain this service.



The No 8 Bus

While the return of the No 8 bus is welcomed, it does not serve Sandycove and Glasthule. And, indeed, there is a total of only 7 No 8 buses on weekdays and none of at all at weekends. And so, therefore, we say "O No 8, No 8, wherefore art thou No 8?"

Georges Street to Reopen

We understand that plans are afoot to open up Georges Street for traffic. Apparently, some of the business community feel that this will restore what retailers call "footfalls" to main street and increase sales. We wonder. What many would say is really needed is adequate 1 to 2 hour parking.

Clamping

At the last County Council meeting Councillors voted to introduce clamping to Dun Laoghaire. While this clamping penalty will only be imposed on motorists who have failed to pay for their third fine, we wonder if this is just the precursor to all-out clamping as has happened in Dublin and indeed under the Dun Laoghaire Harbour Board's jurisdiction.

LOCAL ELECTIONS JUNE 2009

We intend doing the same for the local elections in a future issue. We also have five Deputies (one of whom will certainly disappear at general election time when Dun Laoghaire becomes a four seater) who you can contact at Leinster House.

HUDSON ROAD PLAYING FIELD Brothers Win Action

While the future of the playing fields on Hudson Road has had national media coverage, the outcome is still pretty much up in the air. Obviously, we are anxious that these grounds be retained for sporting facilities for use in our area. This in effect is the only green space available in this part of Dun Laoghaire. Your Association is trying to obtain a copy of the legal advice which was provided to the County Manager, Owen Keegan, prior to his seeking the variation to retain the fields as sporting facilities and the subsequent advice he got not to defend the variation was presumably from the same County Council legal advisers. The majority of Councillors voted with the County Manager's proposal and many of them would now appear to have egg on their face and are looking foolish indeed through no fault of their own.

LAW AND ORDER

Residents are warned to be on their guard to callers who ask to inspect utilities such as water pressure, ESB and gas meters. Some of these callers are plausible but bogus and will steal from you in what has bee dubbed *"yellow jacket crime"*.

Green Coast Management Plan for Sandycove Beach for 2008

The Sandycove and Glasthule Residents Association was recently asked to comment on the Green Coast Management Plan for Sandycove Beach for 2008. We were glad to be invited to comment but surprised that we were given only two days in which to prepare our comments.

We said that the biggest problem on Sandycove Beach is the consumption of alcohol by rowdy groups and the subsequent intimidation of visitors to the beach during the peak season. The local Gardai make regular visits to the beach but this does not stop the vandalism, intimidation and nuisance, in particular to families with small children.

Water sampling should be carried out on a weekly basis and the results displayed on the

notice board. Excess seaweed, pictured here, and the piling up of sand should be dealt with on a regular basis. Parking must be organised so that the ambulance and fire brigade services have instant access to the beach and the Forty Foot, if required.



Why is the construction of the lifeguard's hut taking so long? Will it be completed in time for the summer season of 2008?

The County Council replied that unfortunately there is no way to stop gangs drinking alcohol completely, but the Gardai have increased their presence in the area and have adopted a "zero-tolerance" policy with regard to the public consumption of alcohol and fines for the breach of this bye-law have increased hugely in the past year. The County Council told us that water quality sampling is done each week during the bathing season from June to August and results of these samples are posted on the Sandycove notice board each week. We were told that the lifeguard's hut was nearing completion and that delays had been due to difficulties with the contractor beyond the Council's control. They also said that beach maintenance staff endeavour to move seaweed as soon as it becomes a nuisance.

FESTIVAL OF WORLD CULTURES

We are looking forward to again welcoming the very successful Dun Laoghaire Rathdown Festival of World Cultures. Over the last number of years this has been a tremendous success along with the poetry festival in April. Litter control, Gardai vigilance and overall event organisation was appreciated and brings much needed activity to Dun Laoghaire. However, we did hear from a number of residents on the seafront that tidying up left something to be desired in some areas.

Lighting at Newtownsmith

Councillor Jane Dillon Byrne told us that she recently asked the County Manager about the public lighting scheme at Newtownsmith, which appears unable to withstand the exposed weather conditions and continually has a number of lights not working, and that the Council replaces the existing standards with a more robust variety of lamp. A senior Council engineer replied that the ornamental lighting at Newtownsmith coastal pathway has been functionally problematic since installation with the high outage levels, particularly after windy and wet weather. The two pin inserted socket holder lamp shakes free of its holding due to the lamp heat and the wind with consequential outage and wire cover melt, short circuit etc. A meeting with the manufacturer's agent, the Council and the Council's public lighting maintenance contractor is scheduled. It is hoped to replace the flawed lighting with a more modern alternative with greater security and longer-lasting lamp life. If this is not feasible then replacement with a different lantern will be investigated, ordered and installed in due course. We trust the County Council will not incur additional costs.

CONGRATULATIONS

Footpaths, traffic lights and bus stops

From time to time, through necessity, we have to be critical of our Councillors and our County Manager and County Council officials. However, it is nice to be able to congratulate Councillors and officials for jobs well done to improve the amenities in our area. We would like to include amongst those to highlight the large investment in renovating corner footpaths with tactile pavements and lowered to facilitate wheelchairs and pushchairs. Likewise the traffic lights near the Link Road and Newtownsmith junction. Also Bus Eireann have carried out further improvements to the majority of bus stops in our area and, indeed, in some cases have added shelters. However, Bus Eireann, can we not have timetables fixed to the new yellow bus stops to give some indication of the approximate arrival of our transport service?

PLANNING NEWS

The Crossroads Committee must be pleased with the recent decision by An Bord Pleanala to turn down the development for the old school building at the junction of Adelaide Road and Eden Road.

We also note that planning permission is again being sought for the area adjacent to Link Road and fronting onto Newtownsmith, pictured here. We examined these proposals and are pleased that, while two perfectly good houses are to be demolished, the proposed replacement buildings appear to keep within the height restrictions. We will be watching this development.



ST MICHAEL'S HOSPITAL, DUN LAOGHAIRE

While Council planners have rejected the application to build an 8 storey apartment block on the site of the hospital car park, the threat to St Michael's still remains. Some Councillors, however, are stating that St Michael's is now safe. But we still feel (on the basis of other hospitals being scheduled for closure while in the process of building new operating theatres) that we must continue to be vigilant, to endeavour to maintain in the long-term St Michael's Hospital for Dun Laoghaire as a hospital offering A&E facilities, in addition to the other work that it does.

FUTURE PLAN FOR DUBLIN BAY



The Sandycove and Glasthule Residents Association, with assistance from some local residents, made a submission to Dublin City Council in November 2007 in response to a request for submissions on proposals for a future plan for Dublin Bay.

These are highlights of the submission.

The entire Dublin Bay region is a public amenity and therefore increased access and usage of amenities such as beaches, cycle and walk ways, water sports, fishing etc should be foremost. Such development is welcome and acceptable provided there is no development on the sea side of the DART and no vehicular usage. We are particularly opposed to privatisation of the foreshore area whether by sale or lease, and we do not accept residential development on the seaward side of the DART line in the Booterstown to Dun Laoghaire frontage. We believe it is totally unacceptable to permit private residential developments on such public marine resources such as the Carlisle Pier, the public baths sites, and Bullock Harbour.

The Dublin Bay Bill 2007 provides for the establishment of a Dublin Bay Authority. That Authority should be accessible with representation from all the relevant stakeholders including residents associations such as Sandycove and Glasthule Residents Association.

The plan for an 8-storey residential development on the site of Dun Laoghaire Baths, which was withdrawn by Dun Laoghaire Rathdown County Council after overwhelming public protest, was intended to raise substantial revenues for the County Council and private developers. The vision and motivation for exploitation and development of Dublin Bay amenities should not be for profit, but to leave a great legacy for future communities.

Infill of the scale proposed may have extreme unforeseen effects long term. All development proposed must contain (in an integrated planning way) the necessary public amenities and infrastructure. All amenities developed should take into account local community needs and interests and must include provision for people with disabilities.

In conclusion we wish to be included and participate in the process of defining this vision and plan for Dublin Bay.

ANNUAL GENERAL MEETING 26th April 2007

Ursula Maguire, Chairperson, opened the meeting by welcoming the large attendance present, including local Councillors and candidates for the forthcoming General Election.

Apologies were received from Eamon Gilmore TD, and Councillors Cormac Devlin and Mary Mitchell O'Connor.

A moment's silence was held on behalf of all deceased members of the Association, including Nancy Bourke and Leo Dolan.

As this was the last residents' meeting to be held in Presentation College, which was due to close at the end of June, Ursula Maguire thanked Jim Murray, Principal, and Secretary, Kathleen Maher, for their kind cooperation during past years. As St Paul's Parish Centre was recently officially opened, it was hoped to hold the next residents' gathering there.

Ursula Maguire thanked all connected with the production of the newsletter, and, in particular, all who delivered it, and asked for more volunteers to help distribute future editions.

It was stated that there was no further news on the Dun Laoghaire Baths site, other than that a committee of local Councillors were considering all aspects. There was good news regarding Presentation College which was to remain in educational use. There was no news about the future of the sports field at Hudson Road.

Paul O'Callaghan presented the Treasurer's report which was accepted.

Ted Courtney was elected a member of the Committee. Ursula Maguire thanked Paul Martin who was leaving the Committee for all his hard work over his period of time on the Committee. All officers and other members of the Committee were re-elected.

The awards for the best gardens and best business premises were presented. These were reported in our last newsletter. All sponsors of the awards were thanked.

When the meeting was opened to the floor, many items were discussed – traffic, parking, pay and display, the appearance of double yellow lines on many roads locally and the general opposition to car clamping; litter and dirt on the streets of the area; the present whereabouts of the No 8 bus and its disappearance from the direct route from Dalkey to Dublin.

There was a long discussion on planning projects, in particular the former Post Office site on Adelaide Road; the site of St Brendans opposite it; the site of the Hall of St Paul's Church; Barkel Motors; 1 Rosmeen Gardens; and the ongoing opposition to work being carried out on a house in Coldwell Street. Mary King gave a short presentation on the local opposition to plans proposed for Kilmarnock House in Killiney.

All Councillors present and prospective candidates for the General Election contributed to the general discussion.

Ursula Maguire closed the meeting by thanking everyone for their attendance.

RESIDENTS GATHERING IN NEW ST PAUL'S COMMUNITY HALL

There was standing room only at the residents' gathering held on Thursday 22nd November 2007 for the first time in the new St Paul's Community Hall which was opened earlier last year. Due to the closure of Presentation College we were delighted at the invitation of the Committee of St Paul's Community Hall to have the use of their wonderful facilities. In spite of the change of location we had an excellent attendance and indeed we were joined by some new members.

One of the main topics which arose at the meeting was the extreme annoyance at the non-existence of the No 8 bus in the Sandycove and Glasthule area and the fact that even when it did run it was only seven times a day and not at weekends.

There was much discussion on the traffic problems in the area and again the Councillors and County Council were exhorted to come up with the long-awaited overall traffic plan from Killiney to Blackrock. At the moment changes seem to be made in a very piecemeal fashion, including the introduction of double yellow lines, one-way streets and indecision whether or not to open up the main street through Dun Laoghaire.

Anna Comerford of the Crossroads Committee spoke on the history of the old St Paul's Hall, which was built in 1911 and rounded off by updating residents on the actions taken to prevent an unacceptable building on the site of the hall.

Members of the Association Committee spoke on subjects such as their attendance at the recent Active Citizenship Conference (a two-day event) and the Dun Laoghaire Rathdown County Council were congratulated for their initiative in holding the conference. Mention was made of the A to Z services booklet available at County Hall, which lists all the services which are available from the County Council and the relevant contact phone numbers. Residents were urged to make sure they registered for voting at the next election.

It was decided at the meeting that the Association should make a submission to Dublin City Council on proposals for the future of Dublin Bay and a special subcommittee was formed for this purpose. Highlights of the Association's submission can be seen on page 5 of this newsletter.
