ST MICHAEL'S HOSPITAL, DUN LAOGHAIRE

The Sisters of Charity have apparently sold the St Michael's car park to the Sisters of Mercy. Subsequent to that, property developer Noel Smyth submitted a planning application for 8 storey 80 apartments on the site which was turned down.

A very well attended demonstration took place on 14th July, Bastille Day, and many Sandycove and Glasthule residents took part. The march was supported by the Save Our Hospital Group, People Before Profit, Sandycove and Glasthule Residents Association and many other community groups. No doubt this march went some way to discouraging this unpopular proposed high-rise private development. Residents must continue to be vigilant since the application is under appeal. You will recall in our last preelection newsletter candidates were asked where they stood on the St Michael's Hospital issue and, without exception, they were to a man and a woman very supportive of the reten-



PROPOSED ANGLING BAN

Not everyone is aware that the Dun Laoghaire Rathdown County Council is proposing to ban angling from all of its shoreline with the exception of Bullock and Coliemore harbours. We feel this is utterly unnecessary and are unaware of any real conflict between swimmers and anglers. Anglers tend to use beaches where there is little or no swimming. This is an issue of personal freedom and the proposed bylaw is an unnecessary restriction of our freedom. Most residents are appalled. Any anglers we have talked to are furious and perplexed. We will keep you informed.

PRESENTATION FIELD

In the County Manager's report of 11 June 2007 on the proposed variation of the County Development Plan to insert a specific local objective to preserve the playing pitches/sports use of the former Presentation College Sports Field, Hudson Road, Glasthule, it was stated that the reason for the variation would be "to retain the use of the site as playing pitch/sports field in the interest of the proper planning and sustainable development of the area". Rumours are still going around that developers are keenly interested in this site and we would urge residents to be ever vigilant and call upon our ward councillors and their fellow councillors to ensure that this facility remains as an open space and sports and recreational amenity for the young people of Glasthule and Sandycove.

114 submissions (including one from the Sandycove and Glasthule Residents Association) were received by the County Council in favour of the proposal and only 2 submissions were made against the proposal – both of them on behalf of the owners of the land raising numerous objections including a large number of procedural and technical points which were comprehensively refuted by the County Manager.

The Sandycove and Glasthule Residents Association are delighted that the variation to retain the sports use of the ground was voted for by the majority of the 28 councillors. Surprisingly 6 councillors were not in favour. We wonder why?

LONG AWAITED TRAFFIC PLAN

We understand the Gardai have been ticketing cars on Albert Road whose wheels are on the pavement. Of course we are all aware that it is illegal to park on pavements. By taking such action, residents must now park their cars fully on the road, thus in effect turning Albert Road into a one way main road. Surely a proper overall traffic plan from Killiney to Blackrock is long long overdue rather than the tinkering that is going on.

SANDYCOVE NO LONGER EXISTS!

We have noticed that in the recent edition of the Dun Laoghaire Rathdown County Tourist Map, put out by Dun Laoghaire Rathdown Tourism, the Sandycove area has been totally overlooked. We brought this to the attention of the Tourist Office and they have apologised and promised this regrettable oversight will be rectified in the next edition of the map. They have not advised when this will be. We found this omission to be very annoying particularly in light of the fact that the Dun Laoghaire Rathdown Tourism bring out such excellent brochures on walks and points of interest. Since Sandycove received an amount of publicity in respect of its success in the Tidy Towns competition (we were on RTE's Nationwide) tourists might have used this map to visit the area. In addition the Sandycove main street is, after all, 600 metres long and has up to 20 businesses, including a public house, a supermarket, a restaurant etc. We hope that this will be rectified ASAP.

RENOVATION OF KILLINEY HILL OBELISK



We are pleased to congratulate the Dun Laoghaire heritage division of the County Council, the Parks Department and, in particular, architect, renowned expert on follies in Ireland, local resident and a former Secretary of our Association, James Howley, for the conservation works to the Killiney Obelisk. This is one of the prominent and best loved follies in Ireland. Built in 1742 by John Mapas, it provides a dominant landmark from land and sea. We urge residents and visitors to visit the site at the top of Killiney Hill. We eagerly await the return of the bandstand on the East Pier which is currently in the process of being renovated. IS THE LITTER ACT BEING ENFORCED?

Our photo shows plastic ties on a lamppost on Adelaide Road. This is typical of hundreds of ties which were left by political parties following the June General Election. These ties are all over the county, and Sandycove and Glasthule in particular have been inflicted. We wrote to the County Manager asking that he consider bringing in some bylaw that would ensure that political parties removed these ties along with the posters. We put forward the idea that each political party be assigned their own colour for the ties so that miscreants could be identified afterwards. Let's hope and, indeed, insist some action is taken prior to the County Council elections in 2009.



FESTIVAL OF WORLD CULTURES

Congratulations to the County Manager and all those in the County Council who were involved in the annual world culture event which took place in August throughout Dun Laoghaire and the green in Newtownsmith. We offer our thanks to all the volunteers, the waste clearing staff and particularly our local Garda Siochana who ensured that this wonderful event took place without anti-social behaviour. We have received some complaints from residents that the arrangements made by the County Council for picking up litter in streets neighbouring festival events were less than satisfactory. While the festival may present relatively few problems for residents at present we must be vigilant for the future and to this end we will request that the County Council establish specific arrangements for liaison with residents directly affected by the festival.

Derelict Sites

In July we wrote to the County Manager, Owen Keegan, about Ardagh, Newtownsmith to draw the County Manager's attention to the ongoing deteriorating situation with the property which is a visual scar on the environment of the Glasthule and Sandycove seafront and, in particular, is highly visible from the Newtownsmith seafront green. The park, as the County Manager is well aware, is a major amenity for the entire hinterland and was used in August for the Festival of World Cultures. The owners continue to flout the notice of derelict buildings which was issued by the Council over two years ago in October 2005. We called on the Council to initiate proceedings as set out in the notice. The owners have not taken any significant action to remedy the situation and have had more than enough time to act on the notice. At the time of going to print the situation has not been remedied . The neglect of this site certainly does not help in the Sandycove and Glasthule's objective to continue to improve its mark in the tidy towns competition. 
CHARITY WALK FOR BREAST CANCER
