There are not only options A and B—there is an alternative

We comment on the so-called "East Pier to Sandycove Enhancement Scheme"

Your Sandycove and Glasthule Residents Association made a submission on the process of preparing a master plan for the Dublin Bay Area. Our submission was four pages long and we have included the main points in this newsletter for your information (see page 6). In addition to the Dublin Bay submission we were asked to make a submission in relation to the East Pier to Sandycove Enhancement Scheme. Busy times for your committee. Again we include our main observations and requests in this newsletter (see page 4). The deadline for this submission was 1st September and we now await a response from the County Manager and our County Council.

It is interesting to note that the County Council has admitted to receiving over 1,100 submissions on the two controversial options being considered for the East Pier to Sandycove project. Intimations are that there are mixed reactions possibly, as purported in a newspaper, in the area of 50/50. However, Save Our Seafront, of whom many residents in this area are supporters, assisted the County Council by collecting in excess of 400 individual submissions of which over 95% were totally against the A and B options and calling for option C. We wonder therefore how is it possible that the total number of submissions received were on a 50/50 basis, particularly since we understand that the first batch of submissions were under 200 thus necessitating the Council to send out their newsletter incorporating a response form. Surely the Council are not treating these submissions formally handed in by Save Our Seafront as one submission as they did in the case of the 15,000 signatures from the last campaign some years ago.

NOW YOU SEE IT, NOW YOU DON'T

East Pier Bandstand Shelter Collapses



On the afternoon of Tuesday 9th September the long awaited and partially renovated shelter adjacent to the bandstand (shown in the inset above) on the East Pier collapsed. Residents who were on the pier at the time said that just after 3pm they heard a loud crack and the whole structure collapsed. We must be thankful that the area was still sealed off as a construction site and no injuries occurred. We have endeavoured to find out from Dun Laoghaire County Council and the Harbour Board exactly what happened but still await details. As one wry local resident said, "you know, I think that bandstand and shelter had been up for almost 100 years and although the shelter was rusting and the glass had disappeared from the roof, it has withstood the worst of gales". On that particular day there was no severe weather whatsoever! We would be interested to hear what happened. Residents are very disappointed and they are looking forward to the total refurbishment of these East Pier landmarks which traditionally have been a part of Dun Laoghaire Pier and many were hoping that when the bandstand and shelter were complete, the weekly band recitals would recommence.

LOCAL ELECTIONS JUNE 2009

And we hear that SIPTU says that if the County Council outsource waste collection charges may almost double.

The unanimous view was that neither of the Concepts presented in their current format were acceptable. In short the proposals were viewed to

Over ambitious, to the extent that there was no foreseeable way of realising either plan financially or practically.

Not relevant to the central aspiration of the community, which is to revitalise the site of the Dun Laoghaire Baths; not to dilute and disperse resources and energy to the entire area stretching to Sandycove.

Even the Specialist Consultants themselves doubted the feasibility of creating a sand beach area behind the breakwaters. It most likely would be washed away.

The excessive development of the foreshore would devastate the existing ecosystem, and its natural beauty. (It is nevertheless widely known that the existing Newtownsmith coastal park derives from man-made intervention and reclamation.)

Residents do not want the proposals seen as a vague menu for cherry-picking portions in isolation. For example, we would be totally opposed to the provision of the underground car park in isolation (or at all)!

The members wished they had been presented with 'Plan C', that is a modest proposal focused on the Baths site.

bers, held on 15th May 2008 the proposed options for develop- and would offer the following views on what that might contain:

> A focused development around that land stretching from the East Pier to the eastern wall of the Baths site.

> The development would carry the route of the Yellow Path from the Newtownsmith Park through the Baths site to connect with the East Pier. This would divert walkers down from the roadside to this park at the East Pier, and other points.

> A modest development in and around the existing Baths Building to include as far as practical retention of the street level Entrance Pavilion. The development would contain a café and public display space, and could further contain a leisure based activity such as a Seaweed Spa. It is not necessary to construct indoor swimming facilities on the seafront.

> The site of the pools and gardens be comprehensively replanned as a Seaside Park, to include sitting areas, playground, and possibly (in line with many other locations) a short term seasonal sand beach, beach volleyball, etc.

> A breakwater be constructed similar to that in the Concept A, but much smaller in scale. That might be without a sand beach but with a swimming facility such as a tidal pool constructed in concrete within the protection of the breakwater.

County Councillors' responses to our submission

This email was sent to our 6 ward Councillors on 7th October 2008:

Dear Councillor. You will have received a copy of the Sandy-cove and Glasthule Residents Association submission on the baths site and Scotsman's Bay — a copy is attached. We would be pleased to hear from you as a current ward councillor your stance on this submission on a scale of 1 to 10, viz totally in agreement, totally against or whatever.

At the time of going to press we had received 5 responses out of 6.

We received a detailed response from Gene Feighery which, in effect, reiterated the Green Party submission on the baths site made 3 years ago, and which was in concurrence with the submission by Save Our Seafront and Sandycove and Glasthule Residents Association published in a previous edition of this newsletter.

Mary Mitchell O'Connor made specific comments. She agrees with many aspects of our submission. She says we need a more modest development, with maritime gardens and public toilets. She was not sure about retaining cold sea baths and does not like the concept of the beach.

Tom O'Higgins stated he was "in accordance" with many points raised and it was "the general feedback" he had received.

Jane Dillon Byrne was generally favourable to our submission

John Bailey told us he was very pleased with the content and layout of our submission.

It would be remiss of us if we did not draw your attention to the fact that the wishes of our 6 ward councillors, as we have seen from past experience, at times have little or no influence when it comes to decisions pertaining to our area. While they might say they agree with the feelings of the majority of residents, they seldom, if ever, can assure us that this has the backing of the majority of their party colleagues. If this comes to a vote our 6 ward councillors can be outvoted 22 to 6.

We must therefore ask again for our local councillors to speak on behalf of their parties. "Where do you and your colleagues stand on the Baths and Scotsman's Bay proposals?" We ask this because we are aware of at least a number of councillors who are still in favour of apartments or hotel development.

We must also ask since the proposal C, which was agreed to by the Sandycove and Glasthule Residents Association, Save Our Seafront and the Green Party and after 3 years now appears to be more or less accepted by the councillors, why was it necessary to set up a committee of local councillors which took over a year to discuss bringing in an outside consultancy firm which has cost, we have heard, close to €170,000 of taxpayers' (that is your the residents') money. We have been told by Councillor Feighery that she has legal advice that there are legal restrictions which forbid development on the site of the baths which makes us wonder why so much money has been spent on consultants' fees for options A and B. Our plan C was free.

Save Our Seafront said: "From the outset Save Our Seafront has taken the initiative on the baths and seafront issue. Our views are well known. We will continue to be in the forefront."

DUN LAOGHAIRE RATHDOWN COUNTY DEVELOPMENT PLAN 2010-2016

Dun Laoghaire Rathdown County Council intends to review the County Development Plan 2004-2010 and prepare a new County Development Plan. The Council is to carry out a Strategic Environmental Assessment as part of the review process and for this purpose is to also prepare an environmental report on the likely significant effects on the environment of implementing the new plan. At the time of going to press the Sandycove and Glasthule Residents Association was preparing a submission to the County Council in time for the deadline for submissions of 3rd November 2008. We intend to publish highlights of this submission in the next edtion of this newsletter.

GLASTHULE OPERA



Glasthule Opera is well and truly launched. The Pavilion Theatre was packed on Sunday 15th June last for the gala launch of Glasthule Opera. The night was organised by Glenageary resident Anne-Marie O'Sullivan, who is Head of Vocal, Opera and Drama Studies at D.I.T (and who is pictured here at the launch with Minister and local TD Mary Hannifin). The night was the first step in starting an opera company in this area. Five wonderful young singers - 3 of whom had come back from abroad for the occasion took part. They were sopranos Katy Kelly and Sarah Power, mezzo-soprano Raphaela Mangan, tenor Carthaigh Quill and baritone Brendan Collins. The evening was a taster for a full-blown opera festival which will take place next year. Moliere famously said, "Of all the noises known to man, Opera is the most expensive".

DUBLIN BAY TASKFORCE

Sandycove and Glasthule Residents Association were invited to organisations, residents associations were not in any way repbecome part of the inaugural meeting of the Dublin Bay Task- resented and we asked for this to be reconsidered. Dublin force sponsored by the Dublin Regional Authority. Gleeson, Chairperson and Bob Waddell attended. The meeting was chaired by Councillor Bronwyn Maher. The committee was made up almost totally of County Council and Docklands Development personnel.

In addressing the meeting, we stated how disappointed we were that not alone were members of Sandycove and Glasthule Residents Association not on the committee but neither were there any representatives from any of the other residents associations around the Bay. We commented that while the various indigenous animals, birds and fish were represented by specific through our newsletter.

Docklands Development Authority and Dun Laoghaire Harbour Company have agendas of their own and these do not always fit in with the quality of life and the wishes of the majority of residents around the Bay. They state that they hope to come back within 9 months with specific proposals. Here again, they appear to be taking on consultants from the continent. Do we not have that type of expertise here in Ireland?

Another of our requests was for a moratorium on all development around the Bay until the new development plan for the Bay is brought together. We will keep residents up to date

excluded from the Necklace of Villages as described in the proposal. Our area forms a large part of the coastal area on the south side of Dublin Bay and there must be consultation and engagement with Dun Laoghaire Rathdown County Council and Fingal County Council as part of the democratic process. Sandymount Residents Association, for example, and other relevant associations were represented as participants in the process and we request similar inclusion and representation. We are fully aware that our area is used as an amenity for a very significant portion of the

wider city, being an intensively used access point to the amenity that is Dublin Bay. We therefore feel fully justified in calling for our inclusion as a stakeholder in the formulation of a Vision for Dublin Bay.

It is essential that an Independent Strategic Environmental Assessment for the entire Bay area be commissioned as a prerequisite to any final draft of the Plan, in accordance with EU guidelines. This of course must include Dun Laoghaire and the Sandycove area. We would also like to point out that any vision for Dublin Bay should extend to Bray so as to complete the entire amenity area.

This will ensure the development of a model of best practice in working with all the stakeholders to ensure an equitable outcome both for the environment as well as communities in the region.

While we welcome the proposal in the section on "Confronting Climate Change" that flood prevention measures should take the form of a bay-wide approach rather than local-scale developments and would like to see this taken on board as a matter of urgency, the BAR-RAGE option is a 'Trojan Horse' for the reintroduction of the concept of an Eastern Bypass motorway. This is completely unacceptable, as has been repeated over and again. The overall impact of such measures may have

enforces the need for our input and participation in the planning process.

The entire Dublin Bay region is a public amenity and therefore increased access and usage of amenities such as beaches, cycle and walkways, water sports fishing etc should be foremost. This is welcome and acceptable provided there is no development on the sea side of the DART and no vehicular usage. We are particularly opposed to privatisation of the foreshore area whether by sale or lease, and we do not accept residential development on the seaward

The residents of Sandycove and Glasthule are serious impacts outside the area. This re- relevant stakeholders including residents associations such as Sandycove and Glasthule Residents Association.

> The plan for an 8-storey residential development on the site of Dun Laoghaire Baths which was withdrawn by Dun Laoghaire Rathdown County Council after overwhelming public protest was intended to raise substantial revenues for the County Council and private developers. The vision and motivation for exploitation and development of Dublin Bay amenities should not be for profit, but to leave a great legacy for future communities.



side of the DART line in the Booterstown to Dun Laoghaire frontage. We believe it is totally unacceptable to permit private residential developments on such public marine resources as the Carlisle Pier, the Public Baths Sites, and Bullock Harbour. Such developments are being considered, and would directly conflict with the concept of public access to the Bay as a regional resource.

The Dublin Bay Bill 2007 provides for the establishment of a Dublin Bay Authority. Formulation of any policy with regard to Dublin Bay is premature pending the future establishment of the Dublin Bay Authority. That Authority should be accessible with representation from all the

The 7 options proposed for the port area are premature pending the recommendations and outcomes of the Independent Strategic Environmental Assessment. Infill of the scale proposed may have extreme unforeseen effects long term. Residential development on brownfield sites within central Dublin is welcomed instead of uncontrolled spread of population to westwards into adjoining counties. All development proposed must contain in an integrated plan the necessary public amenities and infrastructure. These amenities must go hand in hand with residential development. All amenities developed should take into account Community local

needs and interests and must include provision for people with disabilities. The development proposed must contain provision for schools, public halls clubs, sports facilities and access for the community.

The decision to locate a Regional Incinerator down wind of a proposed community of 50,000+ people raises questions as to the ability to achieve the coordinated planning necessary as envisaged in the draft 'Vision.'

In conclusion we wish to be included and participate in the process of defining this vision and plan for Dublin Bay.

this debate, as did Bob Waddell and Ursula Maguire.

Outgoing Treasurer, Paul O'Callaghan, read out the Balance Sheet for the year with a closing balance of €2,445 in the current account.

A general discussion then took place. Litter was an important concern and Margaret Browne was particularly praised for all her efforts in keeping Sandycove and Glasthule litter free.

Mary Craig instigated a long discussion on the fate of the Patton Flyer. She said there was a real chance that this valuable service could be stopped in the near future as the Flyer did not have a route licence despite such a licence being applied for nearly two years ago. A list of signatures from all present was handed up to be used in the event of a public appeal to the Department. All public representatives locally have been urged to use their influence in the speedy granting of this licence to Trevor Patton.

The loss of the No. 8 bus travelling through Glasthule into Dublin was again raised. This is a constant complaint but Dublin Bus does not seem to hear of it.

Imogen Stuart again brought up the poor state of the gardens at Otranto Place in Sandycove. When originally planted the gardens looked very attractive.

Parking was once again the subject of general concern and, once again, no obvious solution was forthcoming.

The evening concluded with a medley of great music from Brendan Glennon and Jimmy Kelly.

INTRODUCTION

The Sandycove Seafront Residents Association is becoming more active again. A new committee was elected last March and has been meeting monthly, to discuss a number of both new and long standing issues. These meetings are carefully recorded in detailed minutes, which may be inspected by any members of the association.

in addition to making the contents of our meetings accessible, we have decided to prepare and circulate this newsletter. There are two main reasons for this. The first is to let our members know the various issues we are considering, and to invite members to suggest others which they consider to be important. The second reason is to encourage other Sandycove residents to join the association, and take an active part in our activities.

It is our hope that the Newsletter will help to raise membership numbers and focus the committee's efforts on the main issues which affect our area. To have a meaningful resident's association, feedback is required from the wider membership, so that the committee may act on a wider mandate than merely their own judgement.

Most resident's associations only become active when the amenity of the area is threatened by a major change, and at such times, great commitment and energy emerges from the community to campaign against the threat. Once a particular issue has been resolved successfully or otherwise, there tends to be a dropping of of residents activity as campaign fatigue sets in. At the moment there is no major issue, but rather a great many minor issues, which when considered collectively are a significant threat to our area.

Sandycove is a beautiful place, and its popularity seems to be growing every year. It is the main point of access to the sea for a large area of the south city, and attracts arge numbers all the year round but particularly in the summer. Despite the ever increasing numbers of people cass, tourist coachess, dogs, swimmers, scuba divers an canciests, and the problems associated with lager lout and drug abusers, the infra-structure has been totally neelected by the County Council.

The parks and open spaces along the seafront ar neglected, toilets closed, pavings, benches and railing poorly maintained, and lighting and litter bins almost non-existent. In the People's Park and Marley Park, the Council has shown that it can provide public amenity space of the highest quality. It is time that we started to demand that equal attention and financial commitment be focused on Sandycove, which must surely be one of the most popular and heavify used parts of the county.

A large and active association will not only have influence due to the weight of local opinion, but will also be able to make helpful suggestions about the most important issues at stake.

SANDYCOVE RESIDENTS ASSOCIATION

The Sandycove Residents Association was formed under the chairmanship of the late Michael Scott in 1975 when a very carefully considered constitution was drawn up. This defined the geographic boundaries of the membership, which are shown on the attached street map, and set out the objectives. It is worth summarising these for the benefit of those who are unfamiliar with

- 1. To maintain and improve the natural amenities
- To prevent any deterioration of the present residential and suburban atmosphere and character.
- To take all possible measures to serve the interests of the residents of the area.
- To take united action when necessary, in all matters of common interest to the residents and the association.

A few years ago, the association split into two parts, the Sandycove Seafront Residents Association and the Sandycove Residents Association, with the geographic split roughly as shown on the map. There were at the time reasonable grounds for this split, although it has subsequently led to a decline in activity of both associations. It may be desirable to return to a single association. Newever, this is a fairly major issue and should be addressed by the wider membership of both associations rather than their committees. Either way, we would welcome your comments and ideas on this matter.
